#### Market Philosophy

To maintain Market authenticity, neither produce nor products obtained from wholesalers, retailers or other unauthorised persons may be offered, traded or exchanged on Market premises. It is critical to the Market’s authenticity that this Rule applies *at all times*, noting that deliberate breaches of this Rule will incur the severest penalty of being immediately and permanently expelled from the Market.

#### Web Site and App

Please make sure that all your contact details are correct on the website and app. If anything needs to be updated, please email me with the new details. Its no good if your customers want to contact you and all your details are out of date. Also, make sure your **APPROVED** offerings are up to date. I will add items that the committee has approved you to sell, but I won’t know if you’ve discontinued a particular item on your listing unless you tell me.

#### Retiring or selling?

Just a reminder to anyone thinking of retiring or planning to sell their business; **there is no “ownership”** of Market stalls, and **they are non-transferable.**

The right to operate in the Market ceases on any change in ownership. If the new owner wants to come into the Market, a new application will be required and it will then be judged against the Market Rules. This also applies if you sell a share of your business. I advise you to let CRFM

management know asap, well in advance of exchange of the business.  
If in doubt, or you have any questions, ask the Manager.

Advertising Levy (per site per week) \$5

1 x Agency Fee ..... \$50

2 x Agency Fee ..... \$100

3 x Agency (Max) Fee ..... \$150
